On 27 June 2022, the UIC Analytical Forensic Testing Laboratory reported to the Stewards that sample number 125856, taken from the horse Watching The Wheels, 1st place finisher in the 4th race at FanDuel Racetrack on 4 June 2022, revealed the presence of Flunixin and Phenylbutazone in the serum portion of the sample. Pursuant to IRB rule number 603.60 a) 5), the presence of 2 or more NSAIDS constitutes a Stacking violation.

After interviewing and reviewing records submitted by Trainer Max Quinonez, the Stewards find Mr. Quinonez to be in violation of the Trainer Responsibility and Stacking rule and hereby assess him a civil penalty \$500.
