THE YEAR 2014 IN REVIEW

The Illinois Racing Board, an independent agency of state government, enforces the Illinois Horse Racing Act of 1975 (230 ILCS 5/1, et seq.) and its administrative rules (Title 11 of the Administrative Code), to ensure the safety and integrity of pari-mutuel horse racing in Illinois. The Illinois General Assembly establishes public policy in the area of horse racing regulation that is enforced by the Board. The Board licenses racetracks, off-track wagering facilities, advance deposit wagering companies, allocates race dates, and is also responsible for licensing, rulemaking, and supervising the conduct of race meets. The Board also oversees all pari-mutuel activity and ensures the proper allocation and distribution of revenue generated by pari-mutuel wagering.

Every participant in Illinois racing is required to obtain an occupational license. Before a license is issued, every application is reviewed and carefully processed by the Board's licensing department. Also, by statute, fingerprinting is required of each applicant.

A staff of administrative, regulatory, security, and veterinary professionals, in conjunction with Board approved racing officials, supervised the activities at five racetracks conducting pari-mutuel horse racing. Each race conducted at an Illinois racetrack is observed by three stewards, two employed by the Board, one employed by the racing association. The stewards observe the races to ensure that all conduct is in accordance with the rules and regulations.

The Illinois Horse Racing Act of 1975 requires the Board to file a written annual report with the Governor. The report shall include the industry's progress toward the following policy objectives established in Section 1.2 of this Act:

1. *Support and enhance Illinois' horse racing industry, which is a significant component within the agribusiness industry.* Sections 30 and 31 of the Horse Racing Act promote the breeding, buying and racing of thoroughbred and standardbred horses in Illinois, preserving the agribusiness

segment of the state's economy. Purse supplements, owners awards, and breeders awards are paid to owners and breeders of winning horses in certain races limited to Illinois conceived and foaled horses.

2. *Ensure that Illinois' horse racing industry remains competitive with neighboring states.* Through the rulemaking process established by the Illinois Administrative Procedure Act and supervised by the Joint Committee on Administrative Rules, the Board creates new rules and amends existing rules to be more uniform and consistent with other major racing jurisdictions. In recent years, the Board has concentrated on rules regulating wagering, medication, and claiming.

3. *Stimulate growth within Illinois' horse racing industry, thereby encouraging new investment and development to produce additional tax revenues and to create additional jobs.* The Board strives to foster an environment that creates jobs and generates important revenue to the State of Illinois by encouraging racetracks to make use of their vacant off-track wagering licenses. Each racetrack is entitled to receive up to six OTB licenses, except Fairmount Park, which is entitled to seven licenses. Racetracks located in Cook County are entitled to receive up to eight. A total of 43 licenses are available.

4. *Promote the further growth of tourism.* To ensure that adequate funds are devoted to the marketing of horse racing, the Board requires that each applicant for licensure to operate a race meet, submit a proposed advertising and promotional budget during the licensing process.

5. *Encourage the breeding of thoroughbred and standardbred horses in this State.* Pursuant to the Horse Racing Act, breeders awards have been established to promote the breeding of thoroughbred and standardbred horses by Illinois residents.

6. *Ensure that public confidence and trust in the credibility and integrity of racing operations and the regulatory process is maintained.* Public

confidence is essential to a vital horse racing industry. The licensing of all persons participating in pari-mutuel racing and the testing of post-race equine samples are necessary components of the Board's regulatory program. Urine and blood samples are obtained post-race from the winner of every race, the horses finishing second and third in stakes races, and from any other horses selected at random by the stewards.

The Board is a member of the Association of Racing Commissioners International (RCI), the industry's oldest and most prominent regulatory association. The information contained in the RCI database allows the Board to monitor the backgrounds of licensees and to exchange important regulatory and industry information with other jurisdictions.

In 2014, the Illinois handle on all racing was \$623,983,057. In 2013, the handle was \$617,943,710. In 2014, the total handle for advance deposit wagering (ADW) on all racing was \$136,317,694. In 2013, the ADW handle was only \$75,936,632, as it was not re-authorized until June 7th of that year.

The Board continued to struggle with fiscal and budgetary issues. The Board is funded by the revenues generated from the pari-mutuel handle (including ADW), admission taxes and license fees. The Board receives no funding from the State's general revenue fund. As the handle decreased, the Board's revenues declined slightly. In 2014, total taxes paid to the Board were \$5,672,966. In 2013, taxes paid were \$5,706,988.

A total of \$56,750,976 was distributed in purses in 2014. Thoroughbred owners, jockeys trainers received \$40,172,846 in purse money and standardbred owners, drivers and trainers received \$16,578,130. In 2013, a total of \$72,036,761 was distributed in purses, \$48,359,376 to thoroughbred and \$23,677,385 to standardbred. Harness racing was scheduled to start on February 5, 2014. However, due to a contractual dispute between the horsemen and the racetracks, racing did not resume until March 14.

Governor Quinn made several appointments to the Board. Chicago Attorney Thomas

McCauley, Chicago businesswoman Melody Spann-Cooper, and agricultural broadcaster Orion Samuelson were appointed in 2014.

After 31 years in public service, IRB Executive Director Marc Laino announced his retirement effective December 31, 2014. He was with the Board for 28 years, serving as Executive Director for 12 years. For the last several years, Marc served as Chairman of the Association of Racing Commissioners International (RCI) Wagering Security Systems Committee. In 2014, RCI named him recipient of the 2014 Len Foote Award. This award is the highest honor bestowed on racing commission executive directors in North America.

During calendar year 2014, the Board amended rules to protect the wagering public and ensure the safety of the participants, both human and equine. The Board issued 435 rulings for violations of the Board's rules and regulations at both thoroughbred and standardbred racetracks. The rulings include, but are not limited to, riding and driving infractions, general conduct violations, licensing violations, human and equine drug violations, and general business practice violations.

EARNDAWG was voted 2014 Illinois Harness Horse of the Year. He was also voted champion 2-year-old pacing colt. Owned by William and Pat De Long, and Ernest Miller Jr., Earndawg earned \$217,015 for trainer Roger Welch. Earndawg went postward 17 times and recorded eight wins. He won the Orange and Blue Final on Super Night at Balmoral Park and the Abe Lincoln Stake at Maywood Park.

WORK ALL WEEK was voted 2014 Illinois Thoroughbred Horse of the Year. A winner of \$1,131,173 in 2014, this 5-year-old gelding, trained by Roger Brueggemann, went to the post six times and recorded five wins and one second. Owned and bred by Midwest Thoroughbreds, Work All Week won the \$1.5 million Grade 1 Xpressbet Breeders Cup Sprint and earned him the Male Sprint Eclipse Award. He became only the second Illinois-bred to capture a Breeders' Cup event.

LABORATORY

Over the past year the University of Illinois at Chicago Animal Forensic Toxicology Laboratory has conducted one of the most comprehensive equine drug testing programs in the country. The laboratory accomplished this by employing an extensive array of enzyme linked immunosorbent assays (ELISA), as well as the state-of-the-art LC-MS-MS systems, to routinely screen samples for prohibited substances. These tests are highly sensitive and allow the laboratory to screen for a wide range of substances. During the past year, the laboratory began testing equine blood samples for violations exceeding the permitted levels of furosemide, flunixin, phenylbutazone, oxyphenbutazone using the LC-MS-MS. This switch greatly reduced the reporting times for these samples. Also, the laboratory routinely tests for violations of total carbon dioxide (TCO₂) levels. The laboratory continued the updated TCO₂ analysis which now provides the Board with additional information. The laboratory continued to routinely screen for anabolic steroids in an effort to enforce the Illinois Racing Board regulations.

The laboratory continues to assist the track stewards and security personnel in investigating possible doping violations that employ methods designed to circumvent our standard testing procedures. The laboratory also investigates and reports on special items such as syringes, drug vials and other contraband that are collected or seized at the racetracks.

The laboratory continues to participate in the International Association of Racing Commissioners Quality Assurance Program and the International Proficiency Testing Program conducted by the Association of Official Racing Chemists.

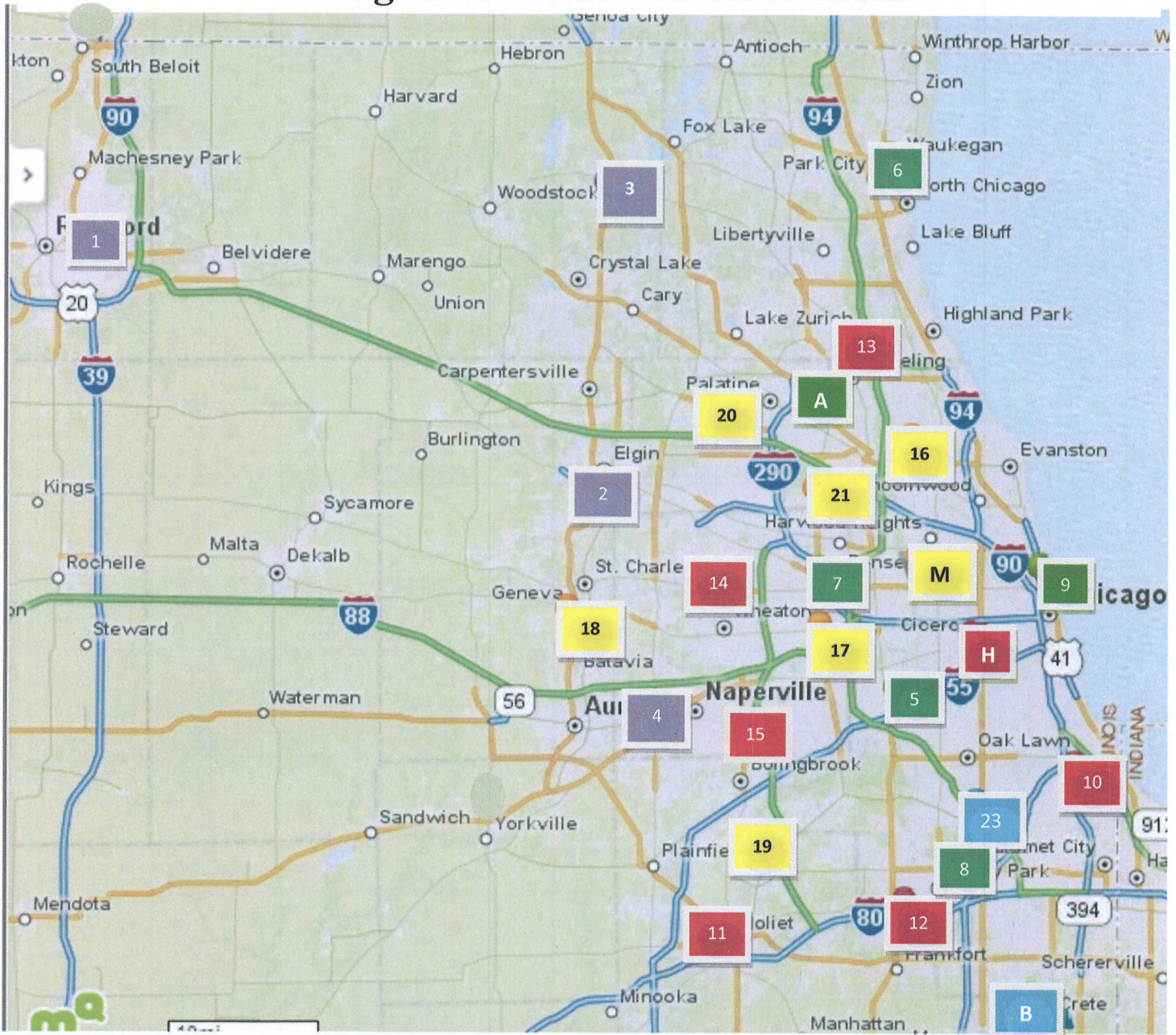

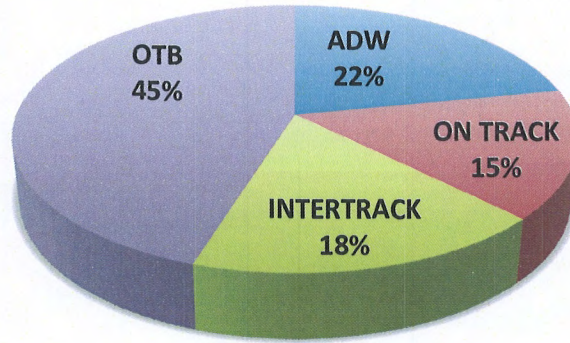

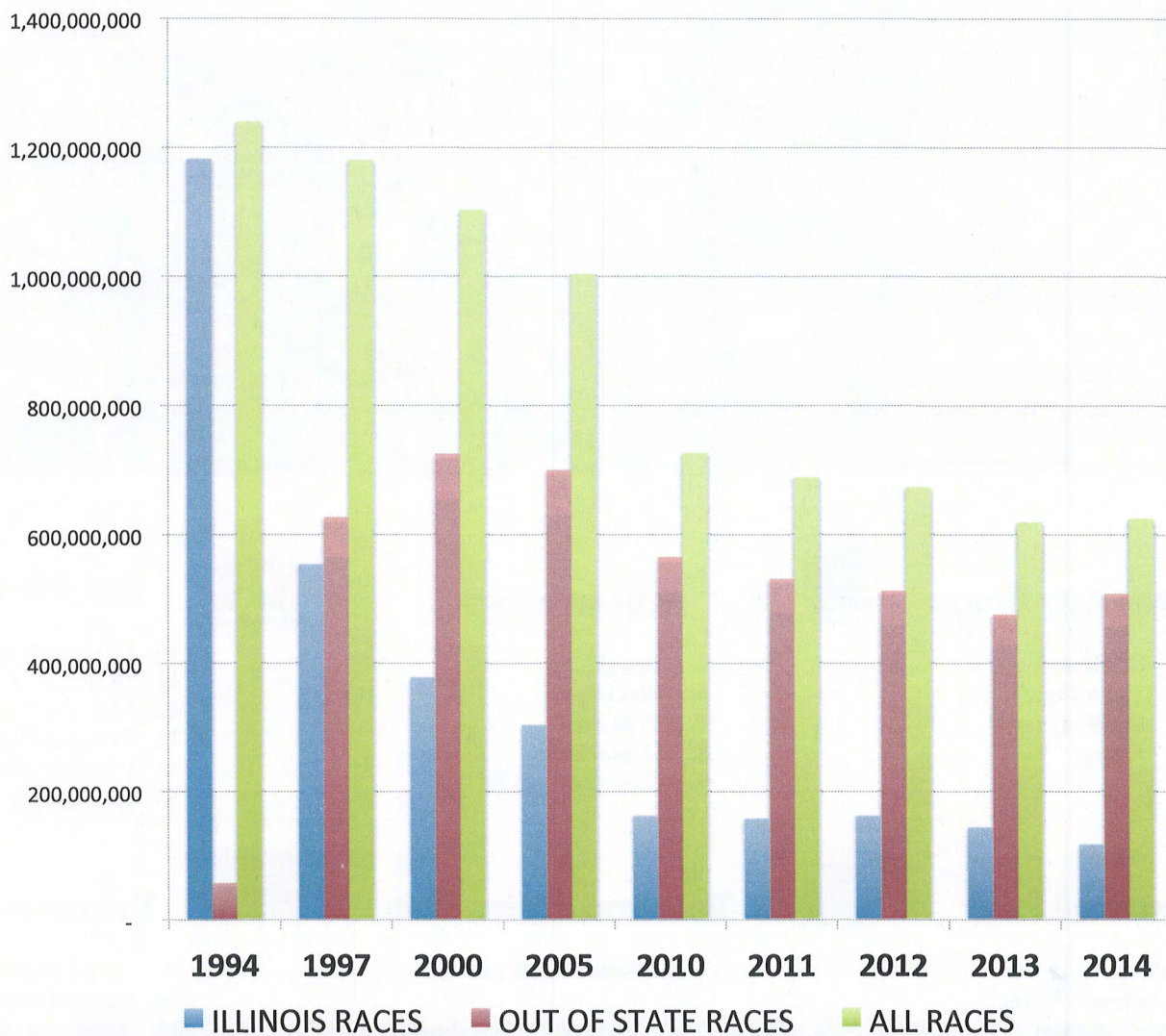

WHAT IS PURSE RECAPTURE?

Purse recapture is a 1995 provision of the law that allows racetracks to recoup losses on live handle brought on by the authorization of full-card simulcasting of races from other states. Handle on Illinois races as a percentage of total Illinois handle has dropped from 95% in 1994 to 19% in 2014. The recapture amount is 2% of the decrease of Illinois handle on Illinois races from 1994. The recapture monies allocated to the racetracks are deducted from the horsemen's purse accounts. In 1999, legislation was passed that authorized annual appropriations to the Department of Agriculture for reimbursement to purse accounts equal to the recapture amounts. The appropriation is an annual decision, the racetracks will always receive their monies, either from the State or from the originally intended horsemen's purse accounts. Below are the annual amounts of purse recapture since 1995, when full card simulcasting was authorized.

2014 ADVANCE DEPOSIT WAGERING (ADW)

Advance Deposit Wagering officially began in Illinois on October 13th, 2009. Four companies were licensed in 2014 as ADW providers. Illinois patrons place funds into an account and then wager on races using a telephone or internet device such as a computer or personal digital assistant. Each ADW provider must have a contract with an Illinois racetrack and their affiliated Illinois horsemen association.

On January 29, 2014, ADW was re-authorized for three years and included an additional .2% surcharge on winning wagers and winnings from wagers to help fund the Racing Board.
