Absent: Commissioners Greg Sronce and Roger Whalen. Staff members Domenic DiCera, Mike Pieczonka, Marc Laino, Bob Lang, and Mickey Ezzo were also present.

#### **BOARD ITEMS**

Representatives of Balmoral Racing Club, Inc. and Maywood Park Trotting Association, Inc. presented a report on their financial status and Chapter 11 bankruptcy proceedings. William "Duke" Johnston, Randy Olech, and Chad Gettleman appeared on behalf of Balmoral Park and Maywood Park.

Commissioner Scates moved to certify the following purse recapture amounts for 2016 pursuant to Section 26(g)(13) of the Illinois Horse Racing Act. Commissioner Swoope seconded the motion.
