ADDENDUM TO RULING #102010 – DISSENTING OPINION

I have carefully and objectively reviewed the entire and cumulative record of the experience and performance in harness racing of driver John B. Roberts. I respectfully dissent from ruling #102010 dated February 10, 2010 and recommend revocation of the drivers license of John B. Roberts because of prior partial exclusions and suspensions due to alcohol and drug abuse problems; his battery and bodily harm to others; his threatened violence and harm to other licensees and other conduct which has been such that his presence on the racetrack creates an unacceptable risk and threat to other participants and to the business, financial and economic interests of racing in Illinois.

I conclude, based upon my review of his entire record that “just cause” exists for the revocation of his occupational license as driver for an indefinite period.
