PURSUANT TO IRB RULE 603.70 D)2) C) INSANE LIFESTYLE WAS PUT ON THE VETERINARIAN'S LIST FOR 180 DAYS AND DECLARED INELIGIBLE TO WORK DURING THAT PERIOD BY THE STATE VETERINARIAN. DESPITE KNOWLEDGE AND NOTICE OF THE NO WORK CONDITION FOR THE VETS LIST TERM, TRAINER JEFF JONES VIOLATED THE CONDITION AND WORKED INSANE LIFESTYLE 3 TIMES DURING THE PROHIBITED PERIOD (9/6, 10/1, AND 11/1). THE 3RD WORK ON 1 NOVEMBER 2021 RESULTING IN THE HORSE'S DEATH. THE CAUSE OF DEATH WAS EAFPH. FURTHER, IN VIOLATION OF IRB RULE 1415.120, MR. JONES ENTERED AND STARTED INSANE LIFESTYLE IN A RACE AT THE DU QUOIN FALL CLASSIC ON 13 SEPTEMBER 2021 WHILE ON THE VETS LIST. AFTER EXAMINING ALL FACTS AND HEARING TESTIMONY FROM INTERESTED PARTIES, THE STEWARDS RULE THAT TRAINER JEFF JONES RACED INSANE LIFESTYLE WHILE ON THE VETS LIST, FAILED IN HIS DUTIES AS THE HORSE'S TRAINER AND DID NOT COMPLY WITH A STATE VETERINARIAN DIRECTIVE. THEREFORE TRAINER JEFF JONES IS HEREBY SUSPENDED IN THE STATE OF ILLINOIS FOR 180 DAYS (28 DECEMBER 2021 THROUGH 28 JUNE 2022). AND ASSESSED OF CIVIL PENALTY OF \$3,000. DURING THE TERM OF HIS SUSPENSION MR JONES IS DENIED ACCESS TO ALL COURSE AND GROUNDS UNDER THEIR JURISDICTION OF THE ILLINOIS RACING BOARD.
