
PURSUANT TO AN APPEAL RESOLUTION AGREEMENT REGARDING RULING 204083, TRAINER EUGENE GILERMAN IS SUSPENDED 30 DAYS (OCTOBER 14, 2020 THROUGH NOVEMBER 14, 2020 INCLUSIVE) DUE TO A LAB REPORT DATED SEPTEMBER 24, 2020 FROM THE UIC ANALYTICAL FORENSIC TESTING LABORATORY THAT URINE SAMPLE #839777, TAKEN FROM THE HORSE MR THREE QUARTERS AFTER THE 7TH RACE AT SUBURBAN DOWNS (HAWTHORNE RACECOURSE) ON SEPTEMBER 4, 2020, REVEALED THE PRESENCE OF ETHYL GLUCURONIDE (A METABOLITE OF THE BANNED SUBSTANCE ETHANOL) IN VIOLATION OF IRB RULES 603.30 (FOREIGN SUBSTANCE BAN) AND 603.50 (TRAINER RESPONSIBILITY).
