### **Section 605.90 Humane Treatment of Horses**

Section

No licensee or other person under the jurisdiction of the Board shall alone, or in collaboration with another person:

- a) <u>subject or permit any animal under his/her control, custody or supervision to be</u> subjected to or to incur any form of cruelty, mistreatment, neglect or abuse;
- b) <u>abandon, injure, maim or kill, or administer any noxious substance to any animal;</u> or
- <u>deprive any animal of necessary care or sustenance, shelter or veterinary care.</u>
- a) No person shall subject any animal to any form of cruelty, mistreatment, neglect, abuse, abandonment, or injury on the grounds of an organization licensee.
